Describe Setting <1 Acres <u>n/a</u> Archaeological Artifacts Present The Walter Maphis House is situated on a terraced rise between two houses along an unnamed lane that runs north from US Route 50, on the west side of the B&O Railroad tracks. In addition to several houses, there are also agricultural buildings in the immediate vicinity of this house.		
Description of Buildings or Site (Original and Present) 2 Stories 3 Front Bays The Walter Maphis House is a two-story, three-bay, gable-roofed frame house built on an L plan that faces southeast toward the B&O Railroad tracks. The house is built on a stone and concrete block foundation, is clad with aluminum siding, and has a composition shingle roof. The one-story hip-roofed front porch is partially enclosed and is supported by modern metal posts. The windows include 2/2 double-hung sash and some modern 1/1 double-hung sashes, which are trimmed with modern metal shutters. The roof is marked by two interior concrete block chimneys, which are not original.

Describe All Outbuildings There is a modern frame shed to the rear of the house.		
Statement of Significance: The Walter Maphis House is not eligible for listing in the NRHP under Criterion A, B, or C. The house is not associated with any events or individuals significant in the history of Romney and/or Hampshire County. The house is also an unexceptional example of a common building type. The Maphis House has experienced numerous alterations that have caused it to lose its integrity of materials, design, and workmanship.
