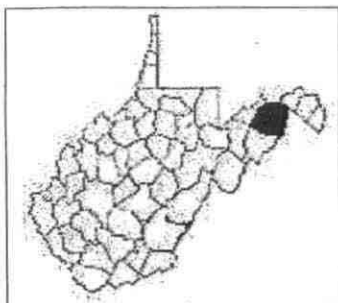

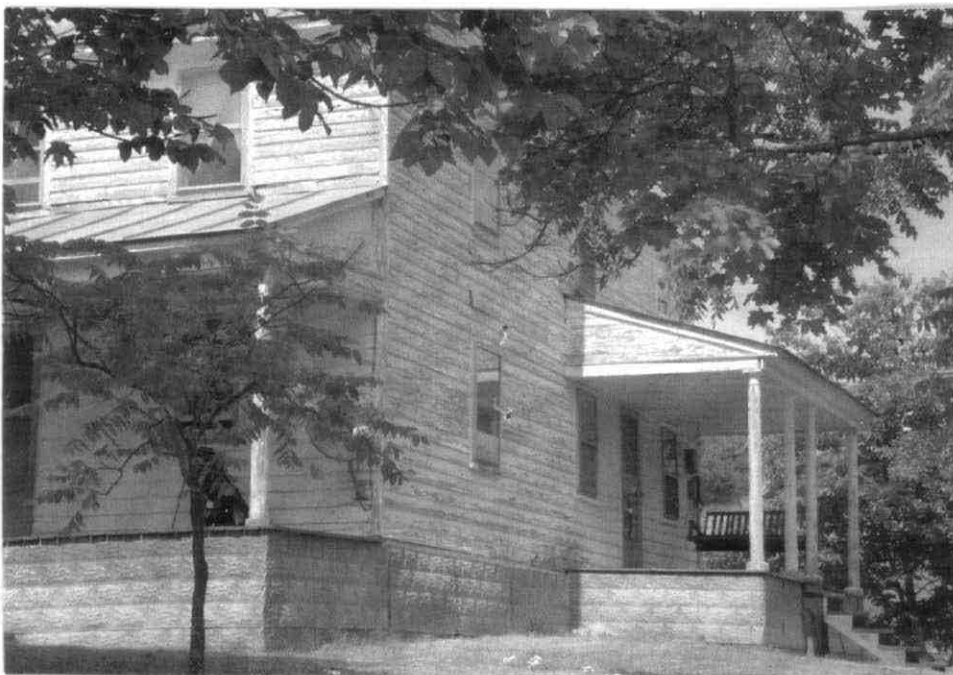

2-story vernacular central passage l-house of wood construction, with a 3-bay façade incorporating a centered entryway which is shielded by a hipped-roof porch which is supported by plain wood replacement piers. An exterior furnace chimney of concrete-block construction extends along a portion of the façade. Fenestration is flat topped, 1/1, with replacement sash.
