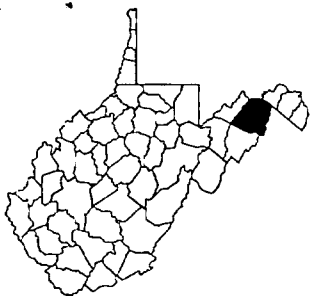

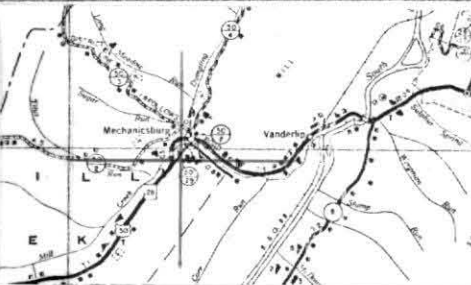

One section has a large stone chimney at its gable end, and it is this section that has rather short 6/6 windows and an apparently newer turned-post porch surrounding the entrance door. The building is on a stone foundation. Log and frame outbuildings are nearby.
SITE SIGNIFICANCE	TIME PERIOD	Early-mid 19th century (?)
	STATEMENT OF SIGNIFICANCE	Based on the physical structure: Distinct sectioning, short windows in the older (?) unit, and the large stone chimney bespeak a well constructed though somewhat primitive farmhouse. Unusual log outbuilding with high brick chimney.
