This building stands on a bluff on the northwest side of US Route 50, southwest of Romney. The bluff descends steeply to the west to a flood plain below.

Description of Buildings or Site (Original and Present) _____ 1 Stories _____ 3 Front Bays

This 1-story, 3-bay wide and 7-bay long stone building is constructed of squared granite blocks laid in regular courses. On the front is a 6/9 sash window, a door with six-pane transom, and a garage door. Other windows have 3-pane fixed sash. There is a garage door on the north gable end.

Statement of Significance

Research conducted at the WVDOH suggests that this garage is unrelated to the highway maintenance garages built by the WPA in West Virginia between 1940 and 1941. These garages typically exhibit a hangar-style roof and central equipment bay. These buildings match the master plans for WVDOH buildings kept at the State Archives. The Hampshire County State Highway Garage, on the other hand, was built in 1937 before the WPA became involved in constructing highway-related buildings in West Virginia. The only feature this garage shares with the WPA-built garages is the use of cut stone construction.

NRHP EVALUATION

The WV State Highway Department Garage is contemporaneous with the installation of the Romney Bridge and is associated with the transition of the Northwestern Turnpike to US Route 50 in the late 1930s. Its association with the transportation and infrastructure improvements in the Romney area in the late 1930s makes this resource NRHP-eligible under Criterion A on the local and state levels. The WV State Highway Department Garage is not associated with a person significant on the national, state, or local level and is not NRHP-eligible under Criterion B. The WV State Highway Department Garage does not possess the requisite architectural significance for NRHP listing under Criterion C.
